NARRATIVE

The victim has been a patient at the South County Medical Center since September 10, 2019. The victim first met the defendant during a pre-scheduled appointment in September, 2019. The victim provided a sworn, recorded statement and attested to the following:

On September 10, 2019, the victim saw the defendant in his office without incident. She went over her medical history with the defendant and he scheduled a gynecological exam on follow up. The victim was pleased after the appointment and felt re-assured by the defendants certifications.

On September 24, 2019, the victim saw the defendant in his office without incident. She advised the defendant conducted a gynecological and breast exam and a nurse stayed in the room the entire time. The victim was advised to follow up with a Mammogram.

On November 05, 2019, the victim saw the defendant in his office without incident. The defendant conducted a breast exam after discussing the results of the Mammogram.

On November 27, 2019, the victim saw the defendant in his office without incident. The victim sought and was provided antibiotics for a toothache and a steroid injection for pain.

On December 16, 2019, the victim saw the defendant in his office. She sought and was provided medical attention for her chronic pain and psoriasis. The victim advised, once the nurse left the room to procure her injections, the defendant requested she lower her pants down to her pubic area to view her psoriasis. He then requested she remove her pants and undergarments completely and lay on the exam table. The defendant digitally penetrated the victim's vagina while examining her pubic area, without her consent. The nurse returned to the exam room while the victim was lying on the exam table exposed. The defendant encouraged the nurse to view the victims genital psoriasis which was visible externally. The nurse administered injections for pain in the victims knee and then left the room. When the nurse left the exam room, the defendant again digitally penetrated the victim's vagina without her consent. The victim stated she felt like she was in shock after the appointment.

On January 13, 2020, the victim saw the defendant in his office without incident. The defendant sought and was provided medical attention for joint pain. During the examination, the defendant requested the victim remove her pants and undergarments while they were alone in the room. She complied but voiced concern regarding the validity of the exam. The defendant did not touch her and concluded the exam quickly.

On January 28, 2020, the victim saw the defendant in his office. She sought and was provided medical attention for joint pain and to go over clinical test results. During the examination the defendant requested the victim remove her pants and undergarments completely and lay on the exam table.

NARRATIVE CONTINUED

He conducted a breast exam and then donned gloves. The defendant placed himself at the end of the lexam table near the victim pubic area and then digitally penetrated the victims vagina while placing his Ithumb against her clitorus. She stated he was rubbing her cervix with two fingers from left to right. He never advised the victim what he was doing. The defendant asked the victim if her cervix was still sensitive, to which she replied "what are you talking about?" He asked if he was hurting her and she advised "no." The defendant then left the room and a nurse came in and administered the victims pain linjections.

The victim advised she sat in the parking lot after the exam and cried.

In March 2020, the victim attempted to contact the defendant at his office with negative results. She ladvised she was curious about the staff reaction to her call and researched the defendant on-line. The victim found an online article stating the defendants license had been suspended by the Department of Health. The victim then called and reported her incidents to the Sarasota County Sheriffs Office.

The defendant, via his attorney declined to be interviewed regarding this incident.

On December 16, 2019 the victim sought medical attention from the defendant regarding chronic pain and a skin condition. The defendant penetrated the victims vagina with his fingers, while the nurse was out of the exam room two separate times.

On January 28, 2020 the victim sought medical attention from the defendant regarding chronic pain, a Iskin condition and to review test results. The defendant penetrated the victims vagina with his fingers land came in contact with her clitorus, while the nurse was out of the exam room. The investigation Irevealed that the defendant went outside the scope of consent given to him by the victim, unwontedly touching the victim and performing outside the typical, common medical practices utilized by a person lacting in the capacity of a physician.

Probable cause exists to charge the defendant, Thomas A. Lohstreter with violation of F.S.S. 794.011 (4)b, sexual battery, as he did penetrate the victims vagina with his fingers on three separate loccasions.
