### NARRATIVE

The victim has been a patient at the South County Medical Center since November 2019. The defendant is the attending physician at the South County Medical Center and became the victim's physician. The victim provided a sworn, recorded statement and attested to the following:

On November 21, 2019, the victim saw the defendant in his office in order to establish herself as a new patient. The victim advised once the nurse left the exam room, the defendant requested the victim lower her pants and undergarments below her hip, and raise her shirt to expose her abdomen. The defendant proceeded to palpate her lower abdomen and moved his hand to the top of her pubic mound. The victim advised she has a mole in her pubic area and the defendant focused on that. She advised the defendant she had it checked previously and did not wish him to examine it further and he stopped. The defendant then had the victim lift her shirt and bra and palpated her breasts. The rest of the appointment went without incident.

On December 11, 2019, the victim saw the defendant in his office for a blood draw and to be treated for an upper respiratory infection. The victim advised once the nurse left the exam room, the defendant requested the victim lower her pants and undergarments below her hip. He listened to her lungs and then proceeded to palpate her abdomen. She advised he was pushing down on her bladder area. He then placed his hand on her pubic mound, pushed down and pulled the skin back, exposing the victim's clitoris. The victim became uncomfortable and advised the defendant that it is the same mole he saw last time and she did not wish him to examine it further. The rest of the appointment went without incident.

On January 10, 2020, I conducted a recorded interview with the defendant in the presence of his attorney. Post Miranda, the defendant stated he did not remember the victim but recognized her name. He initially denied the victim's allegations, and advised he would have a female nurse present if he were doing an exam of the pubic area or breasts. The defendant eventually stated he remembered a female patient "like that." He went on to explain that he remembered a patient who had something "down right at the mons" so he examined it closer. The defendant stated "after I saw it was nothing, it was the top of her clit..." He advised he does not think he touched her "clit", just the area. He advised he made a statement to that particular patient "I saw something down there, but it's only you." The defendant stated there was no female nurse in the room during that examination and he was not wearing gloves.

The victim sought medical attention from the defendant two separate times in 2019. During both appointments, the defendant examined the defendant's pubic area. The investigation revealed that the defendant went outside the scope of consent given to him by the victim, unwontedly touching the victim and performing outside the typical, common medical practices utilized by a person acting in the capacity of a physician. Probable cause exists to charge the defendant with simple battery.
