NARRATIVE

The victim is considered physically disabled by the State of Florida and has been a patient at MCR Health Inc, Englewood since 2015. She was previously attended by Dr. Scott, who retired in September 2019. The victim first met the defendant during a pre-scheduled appointment in the fall of 2019. The victim provided a sworn, recorded statement and attested to the following:

Between the fall of 2019 and March, 2020, the victim saw the defendant in his office at MCR Health Inc, Englewood, several times. Each of the visits prior to March 02, 2020 the victim was accompanied by her husband. The victim described the defendant as caring, and very reassuring. She advised that she "liked him a lot."

On March 02, 2020, the victim saw the defendant in his office and advised she was battered. She sought medical attention due to numbness and tingling in her lips. The appointment was exigent due to her other medical conditions and her husband was not available to accompany her at the time. The victim explained that during the exam, the defendant pulled her shirt and bra up exposing her breasts. He also pulled her bottoms down below her hip line, exposing the top of her pubic area. The defendant proceeded to manipulate the victims breasts with his whole hand. She described the event as "groping and playing with my nipples." The victim stated the defendant's actions were sexual in nature as opposed to clinical. The victim advised that during the course of this interaction, the defendant had pressed his groin area up against the side of her body. The victim stated she emotionally shut down during the exam. She advised she cried in her car on the way home and immediately disclosed the incident to her husband.

She advised she has since been seen in the Emergency Room and was contacted by MCR Health Inc. for a follow up to the ER visit. She was informed the defendant no longer worked there. The victim searched the defendants name on-line and found a media article regarding the Florida Department of Health suspending the defendant's license for allegedly inappropriately touching a patient. The victim then contacted the Sarasota County Sheriff's Office to make a report.

On March 02, 2020 the victim sought medical attention from the defendant regarding numbness/tingling in her lips. The defendant groped the victim's breasts and played with her nipples during the exam. The investigation revealed that the defendant unwontedly touched the victim and performing outside the typical, common medical practices utilized by a person acting in the capacity of a physician.

Probable cause exists to charge the defendant, Thomas A. Lohstreter with violation of F.S.S. 825.1025 (3a) lewd and lascivious molestation of a disabled person as he did intentionally touch, in a lewd manner the breasts of a disabled adult who failed to give consent.
