On 05/29/20, Officers with the Sarasota Police Department met with the victim and [REDACTED]. The victim stated she was sexually battered by a [REDACTED] from the approximate age of [REDACTED] or [REDACTED] years old until age 10. The victim is now [REDACTED]. The victim stated she could no longer live with this secret and she told [REDACTED]. The victim stated [REDACTED] with the defendant Valentin Gonzalez, his wife Vanesa and their two children at 1673 8th St. The victim stated [REDACTED] with the Gonzalez family for approximately five years.

On 06/05/20, a forensic interview was conducted with the victim at the Child Protection Center. The victim stated the following:

1. Gonzalez told her he would be the actor and she could be the actress and they would do things they saw in a Spanish soap opera. Gonzalez started with kissing the victim on the lips with an open mouth.
2. The victim stated the incidents took place in a building/small house in the rear of the property where Gonzalez would do massages on people.
3. The victim stated Gonzalez would put his face between her legs after he would take off her pants and underwear. Gonzalez would put his tongue and mouth on her "area." The victim stated her "area" is her vagina. These incidents occurred on a blue couch, with a beige cover with flowers on it in the small building behind the house. There was one time at the beach (unknown which beach) in Sarasota, the victim said Gonzalez was touching her vagina underneath her bathing suit, with his fingers while they were in the water. The victim does not recall if his fingers went inside her vagina.
4. The victim stated one time they were in a tent in the back yard and Gonzalez unbuckled his pants and pulled his "dick" out and told the victim to "treat it like a lollipop". According to the victim, the penis was erect when he did this. The victim did not touch or perform oral sex on Gonzalez.
5. The victim remembered when Gonzalez and his wife were expecting a baby and he told her "Me and you will have a baby when you are 16."

6. The victim was afraid to tell about what happened because she was close with Gonzalez's daughters' and she did not know what would happen to them.


7. The victim's [REDACTED] noticed a couple of months ago that she was not eating well, she was depressed, and not her normal outgoing self.

8. The victim and [REDACTED] went to 1110 Manhattan Ave where Gonzalez and his family live now. The victim confronted Gonzalez in front of his wife and told what happened to her. The wife, Vanesa Gonzalez asked her husband if this was true and he dropped his head and said "Yes." Vanesa apologized to the [REDACTED] for her husband. Vanesa still lives with her husband and their two daughters.

On 06/22/20, Detective Llovio, Detective Buck and I made contact with Gonzalez and his wife Vanesa at their residence. Vanesa confirmed everything the victim stated. Vanesa stated the victim and her [REDACTED] came to their house and her husband said "Yes" when confronted about the molestation. Vanesa stated later that day, after the victim and her [REDACTED] left Gonzalez kept apologizing to her for what he had done. At that time, Gonzalez was placed in handcuffs and transported to SPD for interview.

Detective Llovio interviewed Gonzalez after he waived his Miranda rights. Gonzalez stated the following:

1. Gonzalez confirmed that he [REDACTED] the victim and [REDACTED] at the house on 8th Street.
2. Gonzalez confirmed it all began when she approached him in the living room of the house, and asked him to play the soap opera game, which meant she would be the female and he would be the male. Gonzalez stated the victim was [REDACTED] when this started, and lasted approximately six months.
3. Gonzalez admitted to touching the victim's vagina with his hand over her clothing three times.
4. Gonzalez admitted to touching the victim's vagina under her clothing with his hands two times.
5. Gonzalez admitted to performing oral sex on the victim three times. Gonzalez said the victim liked it and would push his head down to her vagina.
6. Gonzalez admitted to exposing his penis to the victim and asked if she wanted to grab it, the victim said "No" and he did not insist.
7. Gonzalez confirmed that the sexual acts occurred in the living room of the main house, the victim's bedroom and the detached building in the back where he would do massages.
8. Gonzalez stated that he never forced her and he never raped her.
9. Gonzalez said he never thought about his actions being wrong until a year later.
10. Gonzalez showed little to no remorse for his actions.

Affiant believes probable cause exists to charge the defendant with Sexual Battery

At the time of the crime, the victim was under the age of 12, and the defendant was over the age of 18. The defendant intentionally touched the victim's vagina with his hands, mouth and tongue. The defendant showed his penis to the victim and asked her to grab it.

The incidents occurred in the City of Sarasota, State of Florida.
