On 07/30/2020 at approximately 5:00PM Ofc. Litherland responded to 2 [REDACTED] Canoe Lane, North Port, Florida and took a report of a lewd or lascivious incident. The complainant/mother, [REDACTED] [REDACTED] said that her daughter/victim, [REDACTED] had witnesses the defendant, w/m Nikolai L. Karchurin (DOB 07/31/2001) masturbating in front of her in the woods behind 2 [REDACTED] Canoe Lane, North Port, Florida recently, but the complainant was unsure of the exact date.

Based on the statements made by the juvenile victim, a Child Protection Team (CPT) interview was arranged for the victim. On 08/07/2020 at 1:30PM I met with the victim and her mother at the CPT main office in Sarasota. Forensic Interviewer, J. Mateen, conducted the interview with the victim. under 16 years of age for sexual act, and lewd or lascivious exhibition (F.S.S. 800.04(7)(b)). The defendant did forcibly move and confine the victim to the side of the house while he solicited her for oral sex as he was engaging in masturbation in front of her. He also molested her on multiple occasions when he rubbed her breasts and buttocks, over and under her clothing. The defendant also masturbated in front of the victim at least ten (10) other times while they played together in the neighborhood. These crimes did occur in the city of North Port, Sarasota County, Florida.
