NARRATIVE

On September 7, 2020, at 1532, the North Port Police Department received a call from [REDACTED] where the caller advised her juvenile daughter's vehicle back window was shot.

Units arrived on scene where they met with juveniles [REDACTED] and [REDACTED] mother. Officers were advised that there was a disturbance at 4182 Magenta Avenue where shots were fired at [REDACTED]'s vehicle. [REDACTED] and [REDACTED] traveled to the address on Magenta to confront juvenile, Kyleen Hakes. According to Kyleen [REDACTED] Dodge Charger circled the block a few times, and then parked at the corner of Benbow Terrace and Polynesia Road facing north [REDACTED] and [REDACTED] exited the vehicle where they stood in the street arguing with Kyleen and Corissa Barry who is Kyleen's mother who were standing on the westside of their yard. Stanley Kalinowski, Corissa's fiancé, heard Kyleen and Corissa yelling came out the front door of his residence. Stanley recognized the subjects down the street then went back inside and armed himself with his Taurus .40 Caliber handgun. Stanley then walked out the rear door then went to the Northwest corner of his property where he fired approximately five rounds at [REDACTED], [REDACTED] and [REDACTED]. At least one round struck the rear window of the Dodge Charger where [REDACTED] was sitting.

[REDACTED], [REDACTED], and [REDACTED] fled the scene returning to the Sherman Oak Drive address where [REDACTED] mother called police.

Stanley was interviewed on scene where he admitted to firing approximately five shots at the subjects.

Based on the physical evidence at the scene and admissions by Stanley, I have probable cause to arrest Stanley Kalinowski for the violations of Florida State Statutes 784.021 Aggravated Assault with a deadly weapon (three counts) and 790.19 Shooting into an occupied conveyance.
