Your Affiant is a detective with the Sarasota County Sheriff's Office.

SMITH, MICHAEL JAMES

Defendant:

On 09/09/2020 your Affiant executed a search warrant at 347 Holly Road Venice, Florida in reference to the possession of child sexual exploitation material. Upon entering the residence a white male, later identified as Michael James Smith was located on a couch. A blue cell phone was located under Smith's body, where he was laying on the couch. Smith's blue cell phone was triaged along with all of the other electronic devices within the residence and it was discovered there were images depicting child sexual exploitation material on the device.

During an initial examination of Smith's cell phone detectives located a total of 301 images depicting suspected child sexual exploitation material. Of the 301 images located, 271 were determined to be age difficult or child erotica and 30 depict child sexual exploitation material as defined in F.S.S. 847.001. These images depict children ranging in ages from approximately 6 years old up to approximately 16 years old. Some of the children are being sexually battered and others are nude and posed in sexually explicit positions with their sexual organs exposed.

During a post Miranda audio/video recorded interview, Smith stated he was given the cell phone from a female friend who resides within the residence. Smith also stated he and the friend were trying to use the "dark web" on the device to purchase fake money and other illegal items. Smith further stated he has looked at pornography on the device but, stated he only searched for "teens" when looking at pornography. Smith stated he believed "if the Internet said they were 18 then they must be legal". Smith was shown images from the device which clearly depict prepubescent children and Smith stated he believed the child was 18 years old.

There were illegal narcotics as well as narcotic paraphernalia located throughout the residence and in plain view. It was discovered Smith is currently on Felony probation for driving while license suspended and possession of a controlled substance.

Based on the above mentioned facts, your Affiant believes probable cause exists to charge Smith with 30 counts of violating F.S.S. 827.071(5) possess control view depiction child sex conduct.
