NARRATIVE

On 09/16/2020 I was contacted by telecommunications to respond to the North Port High School, in reference to a Lewd and Lascivious molestation. Ofc. Fisher was on scene with the complainant, [REDACTED] who advised that [REDACTED] who will hereinafter referred to as Victim, told her that something inappropriate happened with [REDACTED] Travis Rupe. The victim was requested to respond to the North Port Police Department for an interview.

I met with the victim at the North Port Police Department and conducted a recorded, forensic interview in the downstairs lobby interview room. The victim advised she [REDACTED] Travis Rupe, [REDACTED]

The victim was asked why she was there to speak with me, and she advised that [REDACTED] Travis, made her touch him "down there." The victim explained that sometime in July was the first incident. She said Travis called her into his bedroom and made her put lotion "down there," referring to his penis. The victim said while she was putting lotion on his penis, Travis was touching himself with his hand and moving it up and down.

The victim said Travis was lying on the bed with no clothes on, and while he was touching his penis with one hand and moving it up and down, he had his other hand around her, touching her buttocks. The victim said Travis continued to touch himself and her until he "finished" and advised he "cummed."

The victim stated she was unable to remember the first time he made her touch him "down there" but advised the last incident occurred yesterday on 09/15/2020. The victim said she went into the master bedroom and Travis had a small, blue and white piece of fabric that was in the shape of a tube, that he placed onto his penis. The victim said Travis made her touch his penis and she was moving her hand up and down on his penis, until he "finished." The victim said when Travis was done, she left the room. The victim stated that this has happened more than ten times with Travis.

Based upon my investigation, and the statements made by the victim, I find there is probable cause to believe that the defendant, Travis Rupe, did commit the crimes of F.S.S 800.04(5)(c)(2) Lewd/lascivious Molestation, victim 12-16, offender over 18 YOA, 800.04(6)(a) Lewd/Lascivious Conduct by person 18 YOA of older, and 800.04(7)(b) Lewd/Lascivious Exhibition Offender 18 YOA or older.

These crimes did occur within the City of North Port, Sarasota County, FL.
