On 10-30-19, Clefford Nerette was interviewed by Detective Vollmer in reference to a narcotics investigation (19-046455). Nerette signed a consent to search for his cell phone on 10-30-19. Forensic Tech Yang conducted a forensic download/extraction of the phone on 10-31-19. Due to the upcoming trial of Nerette, detectives were asked to conduct a more thorough review of the cell phone extraction for narcotics.

On 5-5-21, I was notified by Detective Vollmer and Forensic Tech Yang of possible child pornography Nerette's phone. They requested I view the pictures to verify these images were in fact child pornography.

On 5-5-21, I viewed the images (three images) Detective Vollmer and Forensic Tech Yang had discovered. I verified these images were in fact child pornography.

Below are descriptions of the three images I viewed on Nerette's cell phone:



She is wearing only a tee shirt and has no pants or underwear on. Her buttocks and vagina are exposed. The camera is at a slight angle and she is looking at the camera as if someone is holding it.



This image is of a young girl who is approximately [REDACTED] years of age. She is laying on her stomach on what appears to be a bed or a couch. She is nude and has her top half of her body wrapped in a red blanket. Her buttock is exposed and there is a nude adult male straddling her bottom half. His erect penis is penetrating her backside.

This image has words in the lower right corner that says 24 video and a web address www.whereisyourwife.com. The young girl is approximately [REDACTED] years of age. She is giving an adult male oral sex. The male is pinching/pulling her nipples.

Once I verified these images were in fact child pornography, we stopped looking at the images and received a child pornography search warrant for the cell phone.

The original narcotics crime that occurred by Nerette happened in the City of Sarasota in July 2019. Nerette's cell locations on the cell phone show that he is back and forth between Sarasota City, Sarasota County, and Manatee County all the time, therefore the possession of the child pornography occurred in both Sarasota and Manatee.

I believe probable cause exists for the arrest of Clefford Nerette Jr for 3 counts of Possession of Child Pornography.

I am sending this PCA to the State Attorney Office for review.
