NARRATIVE

On 6/18/2021 at approximately 2046 hours, the North Port Police Department responded to the 4200 block of South Biscayne Drive, North Port, Sarasota County, Florida, in reference to a shooting. The victim was identified as white male, [REDACTED] who was lying approximately fifteen feet south of Porto Chico Avenue on South Biscayne Drive with an apparent gunshot wound to his head.

Officers learned that [REDACTED], a friend of [REDACTED] witnessed the events in question. [REDACTED] told law enforcement that a red colored vehicle, possibly a red Nissan Cube, pulled up near the [REDACTED] residence and began shooting at [REDACTED]

[REDACTED] said that the victim [REDACTED] was having some issues with his [REDACTED] (Kayla Seylhouwer) new boyfriend, Gavin Smith who has been threatening [REDACTED] for quite some time. The victim [REDACTED] and [REDACTED] agreed to meet a group of the new boyfriends' acquaintances in a "vacant field" in North Port.

[REDACTED] and [REDACTED] armed themselves with concrete bricks which they threw at the red vehicle. The red vehicle began "creeping forward" to make a right turn to head south on Biscayne Drive.

[REDACTED] said that the occupants of the vehicle began to fire multiple gunshots and believes the fourth or fifth gunshot struck [REDACTED] immediately fell to the ground. [REDACTED] was transported to Sarasota Memorial Hospital and is currently on life-support.

While looking for Kayla, at her residence, contact was made with two individuals (identified as Gavin Smith and Navarius Mason). [REDACTED]

[REDACTED] Along with conducting a search of vehicle databases, a red Nissan Cube, bearing Florida tag NZQA92, was found to be registered to Anthony Wick who lived in North Port. Investigative means revealed a possible match to the suspect vehicle and a subject in a police report identified as Javen Paul. Both reside at 5041 Weatherton Street, North Port. registered owner/address of a person who resided in North Port.

At approximately 0730 hours on 7/19/2021, a red Nissan Cube was located in the driveway of 5041 Weatherton Street, North Port FL 34288. Law Enforcement located Anthony Wick and Javen Paul, who were interviewed and [REDACTED]
