## NARRATIVE

On 4/13/2022, North Port Police Department (NPPD) Officer Lagarce received a suspicious incident report and spoke to Department of Children and Families Child Protection Investigator Anthony Miltich. Miltich advised he received information regarding a case involving inappropriate touching from the Charlotte County Department of Children and Families office. The involved parties were [REDACTED] (herein referred to as victim), and [REDACTED] James Bart Dixon, DOB 10/20/1968 (herein referred to as defendant).

Officer Lagarce reported the incident occurred in 2020 at 1414 Halacka Rd. North Port, FL, and involved possible touching and groping of the victim by the defendant in the defendant's pool.

On 4/14/2022, this case was assigned to your affiant NPPD Detective Veigel.

On 5/20/2022, your affiant observed a forensic interview of the victim at the Children's Advocacy Center of Southwest Florida in Fort Myers, FL. The victim began to cry and said, "I really just don't like talking about it if that makes sense". She began talking about different incidents occurring at the defendant's house while she visited in which he touched her body making her feel uncomfortable. The victim talked about a time in the summer of 2020 in which the defendant ran his hands from her hips to her inner thighs in the pool. Later that same night, the victim advised the defendant rubbed her inner thigh with his hand while she slept in his bed with him.

The victim disclosed that while swimming in the defendant's pool at his home during her 12th birthday party, the defendant touched her vagina under her bathing suit with his fingers while he tossed her in the air. She described he placed one hand on her back and one hand lower with two fingers under her bathing suit touching her vagina. She denied penetration. The victim stated the same things happened with the defendant when she was 11 years old.

Your affiant interviewed the victim's [REDACTED] who disclosed the defendant sexually abused her when she was a child in Texas.

Your affiant interviewed the victim's [REDACTED] who disclosed the defendant asked to touch her buttocks when she was 18 years old in Florida.

On 1/13/2023, your affiant interviewed the defendant. He did not recall touching the victim's vagina while tossing her in the pool, but said it was possible. He
