On 12-15-22, Detectives executed a signed search warrant at 2055 Princeton St for child pornography. Detectives seized several computers, electronic storage devices, and Paul Jr's cell phone. Paul Jr's cell phone was on his person at the time contact was made during a traffic stop. Paul Jr signed a consent to search form at the time of recorded interview. As of today's date, Forensic Tech Brian Yang has forensically examined the [REDACTED] computer and Paul Jr's cell phone. I reviewed the videos from Paul Jr's cell phone extraction. The other items seized are still being examined.

I saw numerous videos of hidden camera's in different bathrooms that are recording any person using the restroom and shower. These bathroom are located at his home (5038 Delmonte Ave) and at his place of business (PDF Roofing, 2055 Princeton St). The camera in his home was hidden next to the toilet out of sight. The camera at the business is inside a wall, a hole in the drywall can be seen in the camera view. Paul Jr can be seen looking into the hole to ensure camera angle is where he wants it. Paul Jr is wearing a PDF Roofing gray polo. I am still attempting to identify the individuals from the camera at his home.

The videos from PDF Roofing are of a female pulling up her underwear from using the restroom. The hole angle is the same as the above video that included Paul Jr's face. In the videos the female's vagina is exposed as she pulls up her underwear. She is wearing a pink shirt that is slightly pulled up and has light pink underwear. Her fingernails are painted a light pink and she has a metal watch on her arm that is exposed. The female has no idea the camera is there and that she is being filmed.

I took a photo of the video that showed the hand with the nail polish and the watch. I showed this photo to [REDACTED] to identify the person. [REDACTED] showed me her arm while we stood there and she was wearing the same watch.

She said the nail color in the picture was from when she got married in [REDACTED] confirmed that she did not know a camera was in the wall.

[REDACTED] wishes to press charges against Paul Jr for videoing her without her knowledge and consent in the bathroom where she had the expectation of privacy.

Her hand and arm are visible along with the watch she is wearing.


In March 2008 Paul Jr was arrested for Video Voyeurism in Manatee County. The MSO report is attached to the case file.

Video Voyeurism: A person commits the offense of video voyeurism if that person for the amusement, entertainment, sexual arousal, gratification, or profit, or for the purpose of degrading or abusing another person, intentionally or installs an imaging device to secretly view, broadcast, or record a person, without that persons knowledge and consent, who is dressing, undressing, or privately exposing the body, at a place and time when that person has a reasonable expectation of privacy. A person who is 19 years of age or older and who violates this section commits a felony of the 3rd degree.

This crime occurred in the City of Sarasota jurisdiction.


