On 5-11-23, [REDACTED] and [REDACTED] brought [REDACTED] into the front desk. [REDACTED] had a large hickey on the left side of her neck from a male who they believe is an adult. She met the male on the internet and they have met up in person on the night of 5-10-23. Officer Marcinkiewicz took the initial report. I was contacted while the family was still at the front desk to meet with the family. [REDACTED] and [REDACTED] speak good English but [REDACTED] speaks minimal English.

Detective Llovio (for translation) and I conducted an audio recorded interview with the family in the small room by the front desk at the police department. [REDACTED] was visibly upset at the situation with his daughter. I initially talked to all three together, and then I asked if the mother and father could step out and I speak with [REDACTED] alone in hopes she would reveal more of the truth of what happened. They agreed and stood outside the door. Below is a summary of the interview, refer to DVD in property for the full interview.

[REDACTED] said she met "Juan" on Snapchat about 1 1/2 to 2 weeks ago. She doesn't know his last name. She said he told her she was pretty. I asked her if she told him that she was [REDACTED] years old and she said she doesn't remember but she told him she attended [REDACTED] and was in [REDACTED] grade.

She said the first time she saw him in person was on the Sunday that just passed (5-7-23) at the movie theater (Hollywood 20) on Main St in Sarasota. She said her mom dropped her off at the movies but she didn't actually see the movie, she left the theater once her mom was gone from the area. She met [REDACTED] in the back parking lot and got into his car. She described the car as being a black Toyota 4 door car. She said they drove to the area of a Publix that is near Sarasota Military Academy High School. The Publix area would be at 10th St and N Tamiami Trail. She said they kissed and he touched her breasts under her shirt and bra.

She said he then drove her back to Hollywood 20 before her mom arrived to pick her up.

██████████ said she then talked with him over Snapchat some more and sent him nude images and videos of her in the shower and masturbating.

She said the nude images/videos were at his request and direction on what to do.

She said what happened last night (5-10-23) was they made plans to meet up again. She said he texted her and said he was outside her apartment and to come down. He was parked near the pool area. She said she knew her parents could see her get into his car from there so she had him move to the back of the complex. She said she got into his car and they drove to another apartment complex ██████████ (identified later as the Executive House apartments at 1000 N Lockwood Ridge Rd). She said they parked in the back of the complex and kissed. She said he touched her breasts under her bra and shirt and put his hand on her vagina over her clothes. She said he wanted her to give him oral sex but she didn't do that and she said she did not see his penis. She said when they were kissing he was kissing her neck and it hurt. She said she thinks that is when the hickey formed.

She said her parents and brother were repeatedly calling her so she decided she needed to go back home. She said Juan dropped her off next door to her apartment complex and she ran through a small cut in the fence. She said she hid behind a garbage bin until her parents found her.

██████████ noticed the hickey on her neck when she got home. She said her mom noticed it when they were talking later that evening and ██████████ moved and her hair moved away from her neck. That is when her parents started asking questions and figured out what was going on. They brought her to the front desk of the Sarasota Police Department the next morning.

She described Juan as being younger twenties, darker Hispanic male, thin, with an "Edgar haircut" (short on the sides and bowl shape around ears and head.

Detective Llovio and I searched some of the places that ██████ stated Juan had taken her. We found video of Juan's car at 1300 N Lockwood Ridge Rd and at Hollywood 20.

The video from Hollywood 20 shows (5-7-23):

7:35 pm ██████ buys new ticket at counter, moms leaves theater lobby to head home ██████ walks toward the movie show rooms but doesnt go in. She turns around waiting for her mom to leave the area.

7:39 pm-Black Toyota does a Uturn in front of the theater, was traveling west on Main but turns around in the middle of main to head east.

7:46 pm ██████ walks out of theater lobby and exits theater. She walks west toward the construction area which is next door and then walks toward the rear of the outside of the theater, parking lot area.

Video from 1300 N Lockwood Ridge (5-10-23):

6:55 pm-black Toyota pulls into their parking lot (was heading north on N Lockwood Ridge) and stops in the middle of the road. Passenger door opens and a female ██████ gets out of car and heads to her apartment complex fence.

6:56 pm-black Toyota turns north on N Lockwood Ridge from this parking lot.

Using law enforcement tools it was determined FL tag LQDU04 was in the area both of the dates and times from the videos from Hollywood 20 and 1300 N Lockwood Ridge Rd. A check of this tag shows the owner of this car is Pedro Quezada-Pejay (9-23-81, 3712 11th St Ct E, Bradenton) ██████ said the suspect is in his early twenties.

We searched the address attached to Pedro and it shows he has a possible 23 year old son, Juan Carlos Quezada-Perez (3-21-00). The description that [REDACTED] gave of the suspect hair cut matches the description of Juan in the driver's license photo and he is in his early twenties.

I created a photo lineup for [REDACTED] to review with Juan's picture in it. With permission from [REDACTED] for us to speak with [REDACTED] Detective Laster read the instructions and presented [REDACTED] with a photo lineup. [REDACTED] positively identified Juan in the photo lineup as the person who "picked me up in car".

I believe probable cause exists for the arrest of Juan Quezada-Perez for the Lewd Molestation of [REDACTED] year old [REDACTED]

FSS 800.04(5)(c)(2)-Lewd Molestation: A person who intentionally touches in a lewd or lascivious manner the breasts, genitals, genital area, or buttocks, or the clothing covering them, of a person less than 16 years of age, or forces or entices a person under 16 years of age to so touch the perpetrator, commits lewd or lascivious molestation. An offender 18 years of age or older who commits lewd or lascivious molestation against a victim 12 years of age or older but less than 16 years of age commits a felony of the second degree.
