On 12-15-22, a search warrant was executed at 2055 Princeton St for child pornography. The possible suspect of the search warrant, Paul Clayton Furr "Clay", was stopped during a traffic stop, away from the office for an obstructed license plate. I responded to the traffic stop and conducted an audio recorded interview with Paul in my car. Paul signed a consent form for detectives to forensically examine his phone that was on his person.

A forensic exam was conducted on Clay's cell phone.

There were images of a young girl, my estimation she was approximately [REDACTED] years old. She is along side Paul's wife in many normal photos at the beach, which showed that they knew this young girl. With these pictures were nude images of the same girl (his wife was not in these images). I identified this young girl as [REDACTED]

Detective Llovio and I conducted an audio recorded interview with [REDACTED] at her residence. I had pictures printed out from the cell phone to show her so a positive identification could be made. [REDACTED] confirmed that the images were her and she was at most [REDACTED] years old. She said they are very old pictures and she doesn't know why or how Clay would have them. [REDACTED] knows Clay through his [REDACTED]. She said Clay is [REDACTED] IT guy and helps with fixing their phones and electronics. She believes he could have gotten those images from an old phone of hers years ago when she asked him to fix the phone. She said she took those pictures of herself back then and he did not have permission to have them.

A signed arrest warrant was issued on 12-20-22 for video voyeurism from case number 22-066908, different victim. At this same time SSO Deputy Ellis and Detective Morningstar arrested Clay at his residence we were interviewing [REDACTED]

Clay told them he wished to talk with me again so they transported him to SPD. Detectives took custody of another phone he had in his pocket at time of arrest.

Detective Llovio and I conducted an audio/video recorded interview with Clay at SPD. I read him his Miranda Rights and he agreed to speak with us. He said he wanted to come clean and get this over with. He admitted to all of the video voyeurism on his phone and computers.

I showed him the pictures of [REDACTED] and asked him how he got them. He admitted to knowing she was approximately [REDACTED] in the images. He said he got them off a phone she had gave him to fix for her a long time ago. He said [REDACTED] didn't know he had them.

The 10 child pornography photos are described below, these images all have the same bedding in them:



The possession, control, or intentional viewing of each such photograph, motion picture, exhibition, show, image, data, computer depiction, representation, or presentation is a separate offense. If such photograph, motion picture, exhibition, show, representation, image, data, computer depiction, or other presentation includes child pornography depicting more than one child, then each such child in each such photograph, motion picture, exhibition, show, representation, image, data, computer depiction, or other presentation that is knowingly possessed, controlled, or intentionally viewed is a separate offense.
