On 12-21-22, Detectives executed a signed search warrant at [REDACTED] for child pornography and video voyeurism. Detectives seized cameras, computers, electronic storage devices, cell phones, and other computer related devices. Refer to supplement on what evidence was found on individual items seized.

Property tag 89230-2: white Wyze camera base station with antenna was located in the living room of the residence on a dog cage table. Inside was a Samsung 32 SD card.

This camera was located on a table that was next to the dog crates in the living room. It was located with a cammo colored Wyze camera (property tag 89230-1). Both devices had SD cards in them. The Samsung SD card revealed numerous pictures and videos of persons in Clay's home in various rooms. The photos of [REDACTED] were located SD card inside the base station device. The image shows that a camera was in Clay's home hidden next to the toilet, out of sight, inside what appears to be a toilet plunger container next to the toilet. [REDACTED] did not have knowledge of this camera no did he consent to being recorded in the bathroom where he believed he had privacy.


This image shows [REDACTED] standing at the toilet facing the toilet. He is urinating into the toilet bowl. His face and genitals are in the photograph. The camera is hidden next to the toilet inside what appears to be a toilet plunger holder.

There are a total of 2 images of [REDACTED] that were located on this device. I have not been able to locate the actual video from these images.

I spoke to [REDACTED] via phone and sent him the images of his face from the picture. [REDACTED] confirmed that the images are him.

The date and time on the extraction says 7-3-22 at 11:40:40 pm and 7-4-22 at 12:27:06 AM. There is a date and time on the actual images as well. These images are from the Wyze camera base station SD card. The date and time stamp is from the camera itself not when these images were transferred onto the SD card.

The date and time stamped on the images are 7-3-22 at 15:40:34 and 7-3-22 at 16:27:05.

I am forwarding this PCA to the SAO for review.

FSS 810.145(6)(b) Video voyeurism-“Imaging device” means any mechanical, digital, or electronic viewing device; still camera; camcorder; motion picture camera; or any other instrument, equipment, or format capable of recording, storing, or transmitting visual images of another person. “Place and time when a person has a reasonable expectation of privacy” means a place and time when a reasonable person would believe that he or she could fully disrobe in privacy, without being concerned that the person’s undressing was being viewed, recorded, or broadcasted by another, including, but not limited to, the interior of a residential dwelling, bathroom, changing room, fitting room, dressing room, or tanning booth. “Privately exposing the body” means exposing a sexual organ.


A person commits the offense of video voyeurism if that person:

For his or her own amusement, entertainment, sexual arousal, gratification, or profit, or for the purpose of degrading or abusing another person, intentionally uses or installs an imaging device to secretly view, broadcast, or record a person, without that person’s knowledge and consent, who is dressing, undressing, or privately exposing the body, at a place and time when that person has a reasonable expectation of privacy

A person who is 19 years of age or older and who violates this section commits a felony of the third degree.
