On 12-15-22, Detectives executed a signed search warrant at 2055 Princeton St for child pornography. Detectives seized several computers, electronic storage devices, and Clay's cell phone. Clay's cell phone was on his person at the time contact was made during a traffic stop. Clay signed a consent to search form at the time of recorded interview. As of today's date, Forensic Tech Brian Yang has forensically examined the secretary's [REDACTED] computer, Clay's work computer, and Clay's cell phone. I reviewed the videos from these examined items extractions. The other items seized are still being examined.

I saw numerous images/videos of hidden camera's in different bathrooms and a bedroom. These cameras are recording any person using the toilet/shower, and a female changing in a bedroom. There is a video of a couple having sexual intercourse; being recorded from outside looking through a window. These bathrooms and bedrooms are located at his home (5038 Delmonte Ave) and the other bathroom is at his place of business (PDF Roofing, 2055 Princeton St). The cameras in his home were hidden next to the toilet, out of sight, and in a bedroom hidden under what appears to be clothing or a blanket on the floor. The video of the sexual intercourse appears to be from outside a bedroom window.

I identified the victims of the sexual intercourse video as [REDACTED] and [REDACTED] of Clay and [REDACTED] at Clay's house in a spare bedroom [REDACTED] stays with [REDACTED] house sometimes. The video described below is from Clay's cell phone. There are still images of this same video on Clay's work computer.

Description: The video is of the couple having sexual intercourse. The female is nude and is on top of a nude male obviously having sex. The female has blonde hair. The color of the room is pink, from a pink light in the room. The video is being recorded from the outside of the bedroom. Blinds can be seen in the video because the person is standing outside the bedroom window recording through the blinds. The couple having sexual intercourse is unaware that Clay is outside the window recording.

On 12-20-22, Detective Llovio and I conducted an audio recorded interview with [REDACTED] at her home. [REDACTED] said she knew why we were there; the sex video that Clay recorded. She said she knew about it already because Clay told [REDACTED] about the video after the search warrant. Clay told [REDACTED] because he knew what was going to be uncovered when law enforcement got into his phone. [REDACTED] said the room is pink in color because they have colored lights and that night it was set on pink. [REDACTED] said Clay did not have permission to record them having sex.

On 12-20-22, Clay Furr was arrested for Video Voyeurism (victim: [REDACTED] and 10 counts of possession of child pornography (victim: [REDACTED] Clay agreed to talk to us after his arrest and was transported back to SPD for an audio/video recorded interview. I read Clay his Miranda Rights and he agreed to speak with us. Clay admitted that he recorded his friends at his home without their knowledge and permission. He said he used a camera that is now where his dog kennels are inside his house. Clay admitted to recording the women at his place of work as well without their knowledge or permission using his cell phone. Clay also admitted to recording [REDACTED] and [REDACTED] outside their window at his house. He said he knew they were having sex because he could hear them so he went outside and recorded them through the blinds. The DVD of this interview was placed into property.

On 12-30-22, I conducted a recorded call with [REDACTED] said Clay told him about the above described video after we executed the search warrant on the business [REDACTED] said Clay was acting different. Clay then told him that he was taking pictures and videos of people in the house [REDACTED] said Clay told him that this was going on for the last 6 months [REDACTED] said he did not know Clay was taking the video and [REDACTED] did not give Clay permission to take the video.

I asked [REDACTED] if he wanted to press charges for the video of him and [REDACTED] having sexual intercourse and he said yes.


In March 2008 Clay was arrested for Video Voyeurism in Manatee County. The MSO report is attached to the case file.

Video Voyeurism: A person commits the offense of video voyeurism if that person for the amusement, entertainment, sexual arousal, gratification, or profit, or for the purpose of degrading or abusing another person, intentionally or installs an imaging device to secretly view, broadcast, or record a person, without that persons knowledge and consent, who is dressing, undressing, or privately exposing the body, at a place and time when that person has a reasonable expectation of privacy. A person who is 19 years of age or older and who violates this section commits a felony of the 3rd degree.

This crime occurred in Sarasota County.


