On 12-15-22, Detectives with the Sarasota Police Department executed a search warrant at 2055 Princeton St at PDF Roofing for child pornography. Detective's seized numerous devices during this search warrant. Review of these items led to the arrest of the suspect Paul Clayton Furr "Clay" for 10 counts of possession of child pornography and 6 counts of video voyeurism (6 adult victims who wish to press charges and 5 adult victims who do not wish to press charges). Clay was arrested in 2008 for video voyeurism.

On 12-20-22, Clay was arrested at his residence and transported to SPD for a recorded interview. Clay admitted to the video voyeurism and the child pornography in his possession at the time of the search warrant at his place of employment.

On 12-21-22, Detectives with the SSO and SPD executed a search warrant at [REDACTED] in Sarasota County. Detectives seized more electronic storage devices from Clay's home. A forensic exam is being conducted on all of the devices that were seized. Refer to the supplement to this case for what was seized and what was found on each device.

A forensic exam of a Samsung micro SD card revealed a total of 1770 media files on the SD card, 1731 images and 39 videos. 27 of these videos were child pornography, 3 pornography videos that were unable to determine age, numerous images of [REDACTED] family photos with an infant baby, numerous images of [REDACTED] in a white lab nursing student coat with blue scrubs [REDACTED] is a victim in one of the voyeurism cases and is pressing charges), numerous images of roofs for the roofing business, numerous videos from what appears to be drone footage of roofs for the business.

Description in my own words: 1 minute 10 seconds-A young female approximately 8-9 years old bent over the side of a bed. She is wearing a white shirt and not pants or underwear. An adult male is having sex with her from behind.

I reviewed all 27 videos and with my training and experience verified that all of these videos are child pornography.

On 1-19-23, I spoke with [REDACTED] on the phone separately. Both parties denied having access or using the SD card in question. Both stated Rachel Furr took photographs of them on special occasions.

I then spoke with Rachel Furr by phone. I asked her if she had any knowledge of the SD card that were on top of the computer tower in the living room and who would have used them. She said there were probably a lot of SD cards on there. She said her and Clay both use the computer and the stuff around it. She said her friends and family also have access if they need to use it. I explained to her the child pornography that was found on the computer and she started to cry. I asked her if her friends and family would have put these videos on the SD card and she said no. I asked her if she put these child pornography videos on the SD card and she said no. She said with the pictures and videos of the roofing stuff on there it would have been Clay who would have been using the SD card. Rachel Furr said she took the photos of [REDACTED] family but had Clay edit the photos before the photos were sent to them.



FSS 827.071(5)(a) Sexual Performance by a Child-Possession-It is unlawful for any person to knowingly possess, control, or intentionally view a photograph, motion picture, exhibition, show, representation, image, data, computer depiction, or other presentation which, in whole or in part, he or she knows to include child pornography. The possession, control, or intentional viewing of each such photograph, motion picture, exhibition, show, image, data, computer depiction, representation, or presentation is a separate offense. If such photograph, motion picture, exhibition, show, representation, image, data, computer depiction, or other presentation includes child pornography depicting more than one child, then each such child in each such photograph, motion picture, exhibition, show, representation, image, data, computer depiction, or other presentation that is knowingly possessed, controlled, or intentionally viewed is a separate offense. A person who violates this paragraph commits a felony of the third degree.


