NARRATIVE

I Affiant am a detective with the Sarasota County Sheriff's Office assigned to the Criminal Investigation Section, Special Victims Unit.

[redacted] reported to the Department of Children and Families (DCFS) and the Sarasota Sheriff's Office that [redacted] disclosed to her sexual abuse by [redacted] and defendant in this case, Luke Wren.

[redacted] and the defendant [redacted] The victim sees [redacted] every Thursday and every other weekend. [redacted] stated after returning from [redacted] house the victim expressed not wanting to go back to [redacted] house and complained of her vagina being sore. The victim disclosed to her mother the defendant put his pinky finger inside her pee pee and it hurt. The victim was brought to the Child Advocacy Center on 01/30/23 for a forensic interview conducted by case coordinator Hughes. During the forensic interview the victim disclosed multiple incidents of sexual abuse. The abuse consisted of digital penetration of the victim's vagina by the defendant in the victim's bedroom, the bathroom and the master bedroom. The victim stated the defendant put his pinky in her pee pee hole and pressed "really hard and scratched it". "It hurted a lot". The victim stated on one occasion the defendant put his pinky finger in her pee peep hole, "pressed really hard and kept going in an out" and "it really hurted".

The victim disclosed the defendant performed oral sex on her. The defendant would tickle her then put his tongue in her pee pee. The victim stated the defendant licked her bum hole and inside her privates with his tongue. When asked how it felt the victim replied, "it feels quite smooth". The victim disclosed the defendant stuck his tiny finger in her mouth and it "tastes like salt".

Female and male anatomically correct drawings were presented to the victim. The victim stated she, her mom and [redacted] are girls (female drawing), and [redacted] is a boy (male drawing). On the female drawing, the victim circled the vagina "privates" and on the male drawing she circled the buttocks stating that is where [redacted] touched her with his tongue.

NARRATIVE CONTINUED

In May 2023 I was contacted by a Detective with the Stillwater Police Department in Minnesota. I was advised the defendant's [redacted], reported she was a victim of sexual abuse by [redacted] Luke Wren, the defendant in this case (Stillwater Police Department in Minnesota (case # SW23004968). The defendant began to groom [redacted] of age by being playful, hugging her and kissing her belly. This type of behavior allowed the defendant to slowly overcome natural boundaries before the sexual abuse began.

Between the age of 6-10 [redacted] disclosed having engaged in various sexual acts with [redacted] to include the performance of oral sex, the defendant performing oral sex on [redacted] and as she got older engaging in sexual intercourse with the defendant.

Both [redacted] (victim) [redacted] the defendant, Luke Wren. The defendant used grooming techniques such as tickling and kissing with both children. Both children were approximately the same age when the sexual abuse began. The defendant performed similar sex acts on both of the children.

Currently criminal charges against the defendant Lucas Wren have been forwarded to the County Attorney's Office in Minnesota for First Degree Criminal Sexual Conduct for review. An investigation into sexual abuse allegations against the defendant when he resided in Eau Claire, Wisconsin is ongoing. Both cases involve [redacted]

The defendant has retained counsel and invoked his 5th Amendment right to remain silent with regards to all criminal investigations.

Based on the aforementioned facts probable cause exists to charge the defendant, Lucas Charles Wren with four counts of Sexual Battery on a Child less than 12 years of age as per FSS 794.011(8)(C).
