NARRATIVE CONTINUED						
In May 2023 I was contacted by a Detective with the Stillwater Police Department in Minnesota. I was advised the defendant's prepartment of sexual abuse by Luke Wren, the defendant in this case (Stillwater Police Department in Minnesota (case # SW23004968). The defendant began to groom of age by being playful, hugging her and kissing her belly. This type of behavior allowed the defendant to slowly overcome natural boundaries before the sexual abuse began.						
Between the age of 6-10 disclosed having engaged in various sexual acts with include the performance of oral sex, the defendant performing oral sex on and as she got older engaging in sexual intercourse with the defendant.						
Both (victim) the defendant, Luke Wren. The defendant used grooming techniques such as tickling and kissing with both children. Both children were approximately the same age when the sexual abuse began. The defendant performed similar sex acts on both of the children.						
Currently criminal charges against the defendant Lucas Wren have been forwarded to the County Attorney's Office in Minnesota for First Degree Criminal Sexual Conduct for review. An investigation into sexual abuse allegations against the defendant when he resided in Eau Claire, Wisconsin is ongoing. Both cases involve						
The defendant has retained counsel and invoked his 5th Amendment right to remain silent with regards to all criminal investigations.						
Based on the aforementioned facts probable cause exists to charge the defendant, Lucas Charles Wren with four counts of Sexual Battery on a Child less than 12 years of age as per FSS 794.011(8)(C).
