The Sarasota County Sheriff's Office received NCMEC Cybertip 159572260, by and through Microsoft-Online Operations. Microsoft reported on 01/15/23 at 19:41:52 UTC a Microsoft user utilizing I.P. address 2601:704:480:890:a938:7e83:897e:a914 uploaded one image of suspected child pornography to a Microsoft server. I viewed the image. The image consist of an approximately 10 year old female child being forced to have sex with an adult male.

During the course of the investigation, the I.P. provider was determined to be Comcast. Through legal process Comcast provided the subscriber's name and address of 321 Grant Rd Venice FL.

Detectives were able to ascertain the defendant Andrew Morris resides at the home .

On 08/2/23, I contacted Andrew. In a Post Miranda interview Andrew confirmed his identity and informed me he has resided at the address for approximately 5 years. Andrew stated he utilizes his computer to watch adult pornography and further said he has seen child pornography online, but explained it was not on purpose. He believes the youngest child he has seen, exposing their sexual organs, was approximately 12 years old. I showed Andrew the image associated with the Cybertip. He denied ever seeing that particular image, but stated he has seen similar images while on the internet. Andrew admitted to possibly searching for "teens" and "nude teens." At the end of the conversation, Andrew denied consent to check his electronic devices specifically for child pornography and invoked his right for an attorney.

A search warrant was executed at the residence. In a folder, on Andrew's computer, 2 images of child pornography were located. One image was of an approximate 12 year old nude child wearing red stockings bent over with her vagina and anus exposed. The other was an approximate 12 year old female child lying on a bed with her legs open exposing her vagina.

Based on the evidence and Andrew's statements, I believe there is probable cause to charge the defendant Andrew M. Morris with XX separate counts of violating F.S.S. 827.071(5) Possession of Child Sexual Abuse Material (Child Pornography)

This did occur in Sarasota County, FL.
