On 1-29-24 I was responding to a disturbance at 3284 Elliot St. Venice reference case # 24-8762. The suspect left the area in a Black Pickup Truck bearing FI Tag 25EIGK. Shortly after, additional calls came out for a battery at 1255 Mabry Carlton Pkwy, Mabry Carlton Water Treatment Plant, involving a female driving a Black Pickup Truck. I rerouted my response to the Mabry Carlton Pkwy address.

Upon arrival I drove through two gates that appeared to have been hit by a vehicle. Sgt. Vanik had the defendant, identified as Maegan N Grimes, detained. There were multiple victims on scene who stated they saw a Black truck flying down the road that led to the Water Treatment Plant and crash into a concrete light pole. The defendant exited the vehicle and started running around stripping her clothes off. The victims walked out to see what she was doing, and the defendant started touching and hitting Gregory and Reinaldo. The defendant then grabbed a fire extinguisher from the building, pointed it at the victims, and threatened them. The defendant then ran into the generator room, while saying she was going to start a fire. While the defendant was walking towards a room, the victims all told her not to enter, which she did anyway. Michael followed her into the room where he saw her hit the "system shut off" button, which turned off the water treatment plant. That's when the victims tried to stop the defendant from pushing more buttons, and then the defendant hit Michael in the face. The victims then threw the defendant out of the building.

Sgt Vanik stated when he arrived on scene, he observed the defendant attempting to put her clothes on. She refused to comply with Sgt. Vanik's commands and began pulling away as he was trying to detain her. Sgt. Vanik advised he had to place her on the ground to handcuff her.

Post Miranda, the defendant made several excited utterances to include, "Dude, where's my car? I crashed it into a water plant. Haha!" This statement was audio and video recorded at the jail. The above incident was also captured on video surveillance.

The defendant entered a secure area by ramming two gates with her pickup truck, and then battered three victims while inside that secure area violating F.S.S 810.02(2a) Burglary with Battery. The defendant also willfully and without authorization physically tampered with an electronic device that caused a disruption in any service delivered by a public utility violating F.S.S 815.061(2b.) The defendant intentionally struck two gates with her vehicle causing damage over \$1000.00 violating F.S.S 806.13(1b3.) The defendant also resisted by pulling away while Sgt. Vanik was attempting to detain her violating F.S.S 843.02. The defendant was arrested and transported to jail. This incident occurred in Sarasota County, FL. Additional PCA's were submitted for Battery and Criminal Mischief reference case #24-8762, and Violation of felony probation reference case #24-8816.

On 1-29-24 I was responding to a disturbance at 3284 Elliot St. in Venice. The suspect left the area in a Black Pickup Truck bearing FI Tag 25EIGK. Shortly after, additional calls came out for a battery at 1255 Mabry Carlton Pkwy, Mabry Carlton Water Treatment Plant, involving a female driving a Black Pickup Truck. I rerouted my response to the Mabry Carlton Pkwy address.

Other deputies responded to the Elliot address, and advised me that the defendant, identified as Maegan N Grimes had arrived at the victim's residence and was screaming while hitting his garage door with a rake that she picked up from the victim's yard. The victim exited his residence and observed the defendant break the window on his garage door estimated to cost \$300, so he grabbed the rake from her. The defendant started to hit and punch the victim, while yelling that he cheated on his ex-wife. The defendant got into the victim's boat at one point during the incident and was hanging from it, but at this time no damage was observed. The victim told the defendant to leave the property several times, as neighbors exited their residences due to the commotion. The defendant then left the residence in her Black truck at a high rate of speed while screaming "I found you mother fucker." The victim followed the defendant from a distance to relay her location to law enforcement.

The defendant was located at the Mabry Carlton Water Treatment Plant and was arrested for several crimes committed at that location reference case #24-8761. There is probable cause to also charge the defendant with Battery F.S.S. 784.03(1a1) for striking and punching the victim, and Criminal Mischief over \$200 under \$1000 F.S.S. 806.13(1b2) for intentionally breaking the victim's garage door window.

Post Miranda the defendant made several excited utterances as follows: "He cheated on his wife, ""He'll never learn" and "He deserved it." This incident occurred in Sarasota County, FL. The incident was filmed by a neighbor's cell phone, which was submitted as evidence. Witness statements were also submitted. The defendant was on Felony Probation and was violated reference case #24-8816.
