NARRATIVE

On February 13, 2024, at approximately 1854 hours, I was dispatched to the intersection of Atwater Drive and Brack Avenue to meet with Daniel Romer, here and after will be referred to as Victim #1, who had stated to North Port Dispatch that while driving on Jericho Avenue he was stopped by a male, later to be identified as Kevin Chapman, who here and after will be referred to as Defendant, who lives on the street. The Defendant began to yell at him over him allegedly speeding and during the argument he did produce a firearm from his waist and point it at him and his daughter, Carly Romer, who here and after will be referred to as Victim #2, and make threatening statements.

Upon arrival, I did speak with Victim #1 who stated that he was driving to drop Victim #2 off at volleyball practice when the Defendant walked in front of his car to stop him in front of a house on Jericho Avenue. The Defendant began to yell at him over speeding down the street. Victim #1 stated that during the verbal argument and while standing right outside his vehicle's door, the Defendant did remove a firearm, which was described as a smaller firearm, light in color possibly polished metal, and possibly similar looking to a Baretta, from his waistband and point it at him and Victim #2 and had stated in sum and substance "Till you catch a hollow point through the windshield." Victim #1 then stated he quickly drove way to the intersection of Atwater Drive and Brack Avenue to await Police arrival. Victim #1 stated this incident had placed him in fear for his life. Victim #1 additionally stated he does not know the Defendant's name, but he is known in the neighborhood for yelling at cars who drive down his block and tonight he was described as a male, white, approximately 6'00, and bald with a beard.

I did speak to Victim #2, who stated that while she was in the front passenger seat of Victims #1 vehicle on the way to practice, the Defendant had run in front of their vehicle and began to yell at Victim #1 for speeding down the street. At the end of the argument, Victim #2 stated the Defendant had produced a firearm from his waist and pointed it at the both of them and stated in sum and substance "Till you catch a hollow point tip through the windshield." Victim #2 stated this incident had put her in fear for her safety and felt very threatened. Victim #2 did record the argument on her cell phone which captures the threatening statement being made but does not capture the firearm due to the angle of camera. This video has been collected and uploaded to Evidence.Com.

After speaking to both Victims, I did respond to 5283 Jericho Avenue in order to speak with the Defendant who resided at this address. The Defendant was read his Miranda Rights and did agree to answer my questions. The Defendant explained to



me that he has two daughters who constantly play in the street, and he is tired of all the vehicles who speed down the road. The Defenant stated that he began to yell at a light color Jeep that is always speeding down the street and the driver of the vehicle had stopped in front of his house. The Defendant stated he does not remember what exactly what was said during the argument, however he did state that he removed his firearm from his waistband holster and bring it chest high when he saw Victim #1 take his hands off of his steering wheel. The Defendant did not see Victim #1 or Victim #2 display any weapons. A Ruger .380 Caliber serial #380516020 was found on the Defendant's waistband in a holster when he was searched by Officers.

Based on this evidence, I have probable cause to believe the Defendant has violated F.S.S. 784.021(1)(a), Aggravated Assault with a deadly weapon without intent to kill. The Defendant did intentionally make an unlawful threat by word and act to do violence to a person, coupled with the ability to do so, and the act created a well-founded fear in such person that such violent is imminent and did so with a deadly weapon. The Defendant was placed in handcuffs, double locked, and transported to Sarasota County Jail without incident.


This incident did occur in North Port, Sarasota County, Florida.
