**NARRATIVE**

On Sunday, March 3, 2024, at approximately 1:08AM, officers from the North Port Police Department were dispatched to a family disturbance call at 1640 Justica Street, North Port, Florida 34288. 39-year-old Tonya Nottingham contacted the North Port Police Department stating she caught her 38-year-old ex-husband, Scott Nottingham, having sexual intercourse with [REDACTED] Tonya's daughter is 16-year-old Shaylyn Nottingham.

North Port Police Officers arrived on scene and made contact with Tonya who reiterated the above statement. North Port Police Officers cleared the residence of all occupants. The occupants in the home were Tonya Nottingham, Scott Nottingham [REDACTED] and Shaylyn Nottingham. North Port Police Officers detained Scott at this time and contacted myself, Detective Daniel Boileau, to assume the investigation.

**TONYA NOTTINGHAM INTERVIEW**

On Sunday, March 3, 2024, at approximately 2:38AM, I arrived at 1640 Justica Street, North Port, Florida 34288, and made contact with Tonya Nottingham outside of the residence. Tonya stated [REDACTED] and [REDACTED] Tonya stated she is divorced from Scott but they still live together at the Justica residence and operate as a family unit. Tonya stated [REDACTED] frequents the residence and [REDACTED] Shaylyn on a regular basis. Tonya stated it is common for [REDACTED] to be at the residence when Shaylyn is not home. Tonya stated she observed [REDACTED] texting Scott on a regular basis and following him around the residence in the early months of 2023, which prompted her to monitor their relationship more closely. Tonya stated in August 2023 (approximately) she caught [REDACTED] and Scott laying in Tonya and Scott's bed under the comforters in their master bedroom. Tonya stated [REDACTED] and Scott were clothed at this time. Tonya stated due to the frequent texts and suspicious behavior, she banned [REDACTED] from being at the residence from August 2023 (approximately) to January 2024 (approximately). Tonya stated Scott was at his father's residence in Punta Gorda during most of the day and was not at the residence when she went to bed. Tonya stated she woke up around 12:30AM to discover Scott was not in their bed although he should be. Tonya inquired where he was and entered the closed door of the attached garage. Tonya stated she observed Scott with his pants around his ankles moving in a thrusting motion behind [REDACTED] who was bent over with her pants around her ankles. Tonya stated Scott and [REDACTED] quickly pulled their pants up upon sight of her. Tonya stated she did not see Scott's penis during this incident. Tonya stated Scott was wearing dark colored basketball type shorts with no shirt, and [REDACTED] was wearing jeans and a dark colored t-shirt. Tonya stated she told Scott to leave and Scott went to the master bedroom closet where he changed into jeans and put a t-shirt on. Tonya stated the dark colored basketball type shorts are still located in the master bedroom where Scott changed prior to exiting the residence. Tonya gave me permission to speak with [REDACTED] Shaylyn about the incident. This conversation was audio recorded and submitted to the Property and Evidence Department at the North Port Police Department via evidence.com. After my interview, Tonya disclosed to Sergeant David Brown (NPPD), Scott has illegal

testosterone narcotics inside the Justica residence. Tonya stated he keeps the Testosterone in the master bathroom vanity drawers.

SHAYLYN NOTTINGHAM INTERVIEW

On Sunday, March 3, 2024, at approximately 2:57AM, I made contact with Shaylyn Nottingham outside of her residence at 1640 Justica Street, North Port, Florida 34288. Shaylyn stated she worked today until approximately 7:00PM, before she returned to the residence. Shalyn stated she spoke with [REDACTED] prior to going to bed a few hours later. Shaylyn advised she was sleeping in her bedroom when she was woken up by Tonya (mother) at approximately 12:00-1:00AM. Shaylyn stated Tonya told her she caught [REDACTED] having sex with Scott. Shaylyn stated she confronted [REDACTED] about the incident who would not make eye contact with her and would not answer whether she did anything sexual with Scott despite Shaylyn asking her multiple times. Shaylyn stated [REDACTED] had a wet spot on her jeans near her crotch area. This conversation was audio recorded and submitted to the Property and Evidence Department at the North Port Police Department via evidence.com.

[REDACTED] INTERVIEW

On Sunday, March 3, 2024, at approximately 3:20AM, I made contact with [REDACTED] and [REDACTED] at the Sarasota Memorial Hospital – North Port location. [REDACTED] stated they were contacted by Tonya last year in August (approximately) who expressed concerns about [REDACTED] being "obsessive" with Scott. [REDACTED] stated this caused Tonya to ban [REDACTED] from coming to the Justica residence. [REDACTED] stated Tonya decided in January 2024 (approximately) she would allow [REDACTED] to come to the residence again and [REDACTED] with Shaylyn.

[REDACTED] stated they were contacted by Tonya this morning in the early hours who stated she caught [REDACTED] engaging in sexual activity with Scott. [REDACTED] stated they arrived at the residence and took custody of [REDACTED] and transported her to the Sarasota Memorial Hospital – North Port, so [REDACTED] could participate in a medical examination. Lacey stated [REDACTED] would always answer "no" when [REDACTED] asked [REDACTED] a question she did not do. [REDACTED] stated when she asked [REDACTED] if she did anything sexual with Scott, she was silent and avoided eye contact. [REDACTED] stated she knows [REDACTED] and this was an indication [REDACTED] was lying to her. [REDACTED] gave me permission to speak with [REDACTED] about the incident [REDACTED] stated [REDACTED] had a wet spot on her jeans near her crotch area. [REDACTED] believes [REDACTED] may have peed herself. This conversation was audio recorded and submitted to the Property and Evidence Department at the North Port Police Department via evidence.com.

Memorial Hospital – North Port location in room #7. [redacted] was wearing black cowgirl style boots, blue jeans, and a multiple colored blue long sleeve fishing shirt. [redacted] had a visible wet spot on her jeans near her crotch area. [redacted] stated she has [redacted] Shaylyn Nottingham for a while and regularly goes to their Justica street residence. Shaylyn stated she has developed a relationship with Tonya Nottingham, [redacted] and Scott Nottingham, [redacted] stated she looks at Scott [redacted] and communicates with him regularly via text. [redacted] stated she normally sleeps in the front spare bedroom.

[redacted] stated she has been having a sexual relationship with Scott Nottingham since beginning of 2023 (approximately). [redacted] stated the first time she had sex with Scott she was at the Justica residence late at night alone with Scott in the living room of the home. [redacted] stated she had connected with Scott and when they were saying goodnight, she made eye contact with Scott and then looked at her bedroom. [redacted] stated she did this multiple times to indicate to Scott she wanted him to join her in the bedroom. [redacted] stated Scott went into his master bedroom and confirmed Tonya was sleeping before Scott met [redacted] in the spare bedroom. [redacted] stated her and Scott had sex at this time. [redacted] stated her and Scott have had sex multiple times up and Scott "fingered" her multiples until Tonya banned her from coming to the residence in August 2023 (approximately). [redacted] stated "fingered" means he put his finger(s) in her vagina. [redacted] stated Scott suggested moving their communication to a messaging application called WhatsApp, which she did. [redacted] stated she messaged Scott nude photographs of herself using her phone and messaging them to his WhatsApp account. [redacted] stated she communicated with Scott on a regular basis about their relationship via text message and via messenger through WhatsApp.

[redacted] stated she didn't communicate with Scott much after being banned until Tonya accepted her back in January 2024 (approximately). [redacted] stated Scott has "fingered" her multiple times at the residence since her return in January 2024. [redacted] stated she consumed approximately 4-5 beers this evening and was in the garage alone with Scott while Shaylyn and Tonya were sleeping. [redacted] stated she sat on Scott's lap which progressed into [redacted] pants being pulled down. [redacted] stated Scott "fingered" her while she was bent over in the garage. [redacted] stated Tonya opened the door and walked in on Scott fingering her, which prompted Tonya to call the North Port Police Department. [redacted] stated she does not know if Scott's pants were off during this act. [redacted] stated she was confronted by Shaylyn and was eventually picked up by her parents. [redacted] stated her phone she used to communicate with Scott was located inside the residence at 1640 Justica Street, North Port, Florida 34288. [redacted] described the phone as an Apple iPhone in a black case with white writing stating "Cowboy Pilgrim." This conversation was audio recorded and submitted to the Property and Evidence Department at the North Port Police Department via evidence.com. [redacted] consented to a Sexual Assault Kit to be conducted by the Sexual Assault Nurse Examiner (SANE) at the Sarasota Memorial Hospital – North Port.

NARRATIVE CONTINUED

On Sunday, March 3, 2024, at approximately 4:06AM, I made contact with Scott Nottingham who was detained in the rear backseat of a North Port Police car at 1640 Justica Street, North Port, Florida 34288. I read Scott his Miranda Rights, which he stated he understood. Post Miranda, Scott acknowledged having a [REDACTED] Scott stated [REDACTED] does not have a good relationship with her biological father which caused him to inherit this role. Scott stated he communicates with [REDACTED] in group texts with the other children but does not regularly message [REDACTED] specifically. Scott acknowledged [REDACTED]-years-old and stating he is not allowed to have a sexual relationship with her. Scott stated he has not had any sexual relations with [REDACTED] at any time. Scott stated Tonya was arrested for domestic battery approximately three (3) years ago where Scott was the victim Scott stated he believes Tonya is making everything up to get back at him for that incident despite him telling the officer he did not want to press charges and Tonya knowing the arrest was not in Scott's control. Scott acknowledged Tonya banning [REDACTED] from the residence at one point due to Tonya thinking something suspicious was occurring between himself and [REDACTED] Scott denied anything suspicious occurring.

Scott stated he was sitting in the garage relaxing in the early morning hours today and nothing occurred between himself and [REDACTED]. When confronted about Tonya's allegations, he stated he believes Tonya misinterpreted the situation. Scott stated he suggested to [REDACTED] to wash her jeans because they were dirty, since she had been wearing them for approximately three (3) days. Scott stated [REDACTED] had shorts on under her jeans and did not think it was weird to suggest her to remove her jeans while they were alone in the garage despite the previous allegations. Scott admitted it could be perceived weird knowing Scott and [REDACTED] history. Scott denied having his pants off, and stated [REDACTED] was never bent over in front of him with her pants down. Scott acknowledged using his cell phone to communicate with [REDACTED] and stated it was currently located in the back lanai of the Justica Street residence. Scott described his cell phone as an Apple iPhone with a black case. Scott denied using WhatsApp to communicate with [REDACTED] This conversation was audio recorded and submitted to the Property and Evidence Department at the North Port Police Department via evidence.com.

Based on the aforementioned information, I have probable cause to charge Scott Nottingham with Unlawful Sexual Activity with Certain Minors controlled by Florida State Statute 794.05(1).
