NARRATIVE

On April 8, 2024, I, Detective Z. Robles of the North Port Police Department, was requested to responded to [redacted] in reference to locate a missing juvenile female out of Charlotte County. The missing juvenile, [redacted], (who will herein be referred to as Victim) was reported missing at approximately 20:46 hours on 04/07/2024 by [redacted] Veetha Steiner. The Victim was last seen on Sunday 04/07/2024 at approximately 01:00 hours. [redacted] Ivan Steiner had found history on their computer of the Victim being on Snapchat and Google with search history of the address of [redacted]. Due to the search history of the unknown address, the parents believed the Victim may be at the North Port residence. On 04/07/2024 at approximately 22:13 hours, North Port Police Officers responded to the Kenwood residence and made contact with David Bunn (who will herein be referred to as Defendant.) The Defendant denied the Victim being at his residence. The conversations took place on 04/06/24 and were sexual in nature and invited her to smoke.

Charlotte County Sheriff's Office continued their missing juvenile investigation and Detective Parra Hermida obtained the Victim's Snapchat activity account with the name [redacted]. Examination of the Victim's account activity revealed a conversation with another Snapchat account holder named daveab23248, later identified through Snapchat as the Defendant. Through investigative means, it was confirmed the Victim was picked up via LYFT and brought back to residence off Kenwood.

On 04/08/2024 at 10:15 hours, North Port Police Officers responded to the Kenwood residence per the request of Charlotte County Detective Parra Hermida in attempt to locate the juvenile. Officers knocked on the door, however no one responded. At approximately 14:22 hours, Officer Litherland and Officer Kelly made contact with the Defendant and asked about Victim's whereabouts. The Defendant advised Officers that the Victim left on foot at some point last night and he believed she was 18. Detective J. Dewar and I respond and began speaking with the Defendant and he continued to deny the Victim being inside his residence. During the conversation, the Defendant admitted the Victim was inside the residence, in his bed.

A protective sweep of the residence was conducted due to the exigency of the circumstances for the Victim's safety. The Victim was found sleeping in the Defendant's bed. I asked the Victim if she was okay, and she began crying saying she was drugged and sexually battered by the Defendant. At this time, the residence was secured for a search warrant of the home. The Victim advised me

that he provided her alcohol and when she arrived at the residence, and he began to have sex with her for multiple hours. The Victim stated he penetrated her vaginally and orally on two separate occasions and did not use a condom. The Victim stated she felt dizzy during the encounters and does not remember much detail of the room or the events that took place. The Victim mentioned she tried to leave, however the Defendant did not allow her to leave. The Victim expressed she wanted to return home with her parents. The Victim appeared to be tired and in distress.

North Port Police Department Detectives M. Witkowsy and J. Dewar conducted an interview with the Defendant at 5744 Kenwood Dr. The Defendant was read his rights, via issued Miranda card, and waived his rights. Post Miranda, the Defendant advised the following.

The Defendant stated he met the Victim in Port Charlotte at a park. The Victim and Defendant exchanged Snapchat usernames, which they later used to communicate. The Defendant advised he ordered a "Lyft" for the Victim on Sunday morning (04/07/2024), at approximately 0300hrs. The Defendant was suspicious of the Victim's age and asked her several questions to assure she was 18. The Defendant said he and the Victim "hooked up" and clarified that the Victim kissed him while they were sitting by a fire in his backyard. The Defendant said it was only he and the Victim at the residence at this time. The Defendant advised he did not have sexual intercourse with the Victim, and said she only kissed him. The Defendant said the Victim left his residence after this, at approximately 0330hrs.

The Defendant was questioned if there would be any of his DNA on or inside of her. The Defendant advised if his DNA was inside or on her, it could be because he does not wash the sheets in the bed she was laying in. Additionally, the Defendant advised he has a jar of his own semen in the freezer. The Defendant said, "if someone has semen in them and he didn't have sex with them, then that's the only way he can think of it happening".

Based on the totality of the circumstances, there is probable cause to believe the Defendant, David Bunn, violated the following FL State Statutes:
800.04(4)(a)(1) Lewd and Lascivious Battery
787.03 Interference W Custody of a Minor
787.01(2) Kidnapping


The Defendant engaged in sexual activity with the Victim. At the time, the
