Your affiant is a Detective with the Sarasota County Sheriff's Office. Affiant is currently assigned to the Special Investigations Section and is tasked with investigating various narcotics related crimes within Sarasota County.

On June 17th, 2024, your Affiant applied for and received a signed arrest warrant from Honorable Judge Krug for the defendant in reference to two counts of Sale of Cocaine within a 1,000' of a Specified Area and one count of Unlawful Use of a Communication Device to Facilitate a Felony.

Dep. Anderson of the Sarasota County Sheriff's Office NET unit conducted a traffic stop on the defendant for his warrants and took him into custody, and subsequently transported him to the Sarasota County Sheriff's Office Special Investigation Section for a sworn interview with you Affiant.

During a post Miranda Interview with the defendant, he admitted to selling cocaine in Sarasota County Florida, and would sell from his residence. The defendant admitted that there was an ounce of cocaine located within his residence, along with additional narcotics. Based on the above aforementioned facts, your Affiant believed that further quantities of cocaine and evidence related to the sale of cocaine were currently located within the defendant's residence. Your Affiant applied for and received a signed residential search warrant from Honorable Judge Krug to search the defendant's residence.

During a search of the defendant's residence, quantities of cocaine and additional narcotics were located, along with drug paraphernalia related to the sale of cocaine. The evidence that was located was transported back to the Sarasota County Sheriff's Office Special Investigation Section where a minute portion of the suspect cocaine was submitted into a reliable test kit, which tested positive for the presence of cocaine, with a total weight of 43.2g of cocaine. Suspected MDMA was also located where a minute portion was submitted into a reliable test kit with to positive result of MDMA, with a total weight of 20.9g

Your Affiant finds sufficient probable cause to charge the defendant Scott Swirles with 1 count of FSS 893.135(1b1) Trafficking in Cocaine 28g or More, and 1 count of FSS 893.135(1f1) Trafficking in MDMA 14g or More.

All events took place in Sarasota County Florida.
